Dear Members,

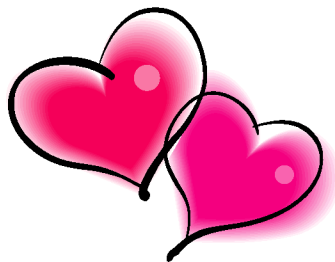
Happy New Year to all! 2009 will bring positive changes, we hope, for us all.
